PART IV: NARRATIVE INTERPRETATION OF ABOVE STATISTICS

The following is provided to the Mayor and Council, on policing initiatives and general policing information. It is to be hand delivered to your community leaders. It is not a private document and can be distributed and displayed in public forums.

- 1. Crime trends / Problems: (Gangs, Drugs, Domestic Violence, Traffic etc.)
 - Turtleford cluster responded to 2247 calls for service in our detachment area during this last quarter an increase of 715 calls for service, Jan 01-Apr 31, the attached numbers are some examples of occurrences we responded too.
 - I have provided comparisons (+/-) to past quarters to show trends in crime, fluctuations.
 - As you can see with this quarter we have a variety of offences, there continues to be drug activity within our cluster/Gang activity has dropped. Members will continue to focus on illegal drugs and gang activity and have planned events to target gang activity throughout the coming months. Combined Unit Resource Enforcement (C.U.R.E) recently concluded with Maidstone and Onion Lake detachments, this initiative helps with traffic/warrant enforcement, visibility in high crime areas, etc. Detachment had 5 check stop initiatives this quarter targeting Impaired drivers, this initiative will commence during the summer months.
 - Traffic enforcement is ramping up with summer holidays here, 946(increase of 700) tickets this quarter.
 - Members continue to focus on prolific offender curfew checks (persons on monitoring conditions) which is effective in crime reduction.

4. Other significant issues: (Infrastructure / Human Resources (including full HR contingent for Detachment)

- The Turtleford Detachment has a total of 13 RCMP members which includes 1 Staff Sergeant, 2 Corporals and 10 Constables. One Constable is in the enhanced positon in the RM of Frenchman Butte (who is transferring out in August). Two of these Constables are assigned to the TCFN. We currently have 1 member off duty sick, no time frame for return and one vacancy from the Thunderchild office (no backfill identified as of report time).
- We currently have a vacancy at the detachment Services Assistant position in Turtleford, interviews are later this week and someone should be in the position soon.
