WHEREAS

Reliable radio communication is essential to the safety of emergency responders and the coordination of effective emergency response, and communication costs are already a significant burden on local municipalities and associations;

WHEREAS

Volunteer fire departments and rescue associations collectively pay thousands of dollars annually in radio licensing fees. User agencies pay \$65.00 per radio per month as set by The Saskatchewan Telecommunications Act and an annual licensing fee of \$41 per radio as required under federal regulation administered by Innovation, Science and Economic Development Canada, invoiced through Saskatchewan Public Safety Agency (SPSA);

BE IT RESOLVED that

SARM advocate to the Government of Saskatchewan to request that the Province pursue the elimination or increased subsidization of radio licensing fees for volunteer emergency response organizations.

BE IT FURTHER RESOLVED that

SARM and the Government of Saskatchewan work collaboratively with the federal government, through Innovation, Science and Economic Development Canada to remove or amend the radio licensing fee requirement for volunteer emergency responders, recognizing the essential public safety services they provide.
