The WSA consumer report for 2022 is posted on the bill board in front of the Pump house. The general chemical test did not exceed any recommended levels except for alkalinity. 513 MG/L to 500 MG/L recommended limit.

Operating permit is renewed to March 2025.

Stacy goes over new bylaws regarding water use.

Bylaw to limit time of outside watering to be imposed if there is excessive demand or equipment malfunction. Bylaw will only be in effect when required. Fines will be issued for non compliance.

Bylaw to have water board members elected for a three year term. Currently yearly, Election will rotate so there will be one board member elected per year.

Question about pump house expense being larger than last year. Pump house is scheduled to get new shingles.
