Call to order: Clinton Smith called the meeting to order at 10:05am

MOTION – Don Taylor/Bill Scheck that the agenda be approved as presented.

MOTION – Ed Chudy/Donna Ritco that the minutes of the May 19, 2013 AGM meeting be approved as presented. CARRIED

MOTION — Bob Taylor/David Crump that the 2013 Financial Report be approved as presented. CARRIED.

#### **Business from Minutes**

<u>Tailgate and Trunk Market</u> – Last year's Trunk Sale on the green space was a success. The organizing committee's intends to have another this summer on the green space. Flyers will be sent out with the date. Participants will be required to pay a small registration fee and to clean up their area.

#### **New Business**

<u>Renewal of Contracts</u> – Maintenance (Don T), and Mowing (Nora), No contract has been secured for the toilet cleaning – Motion Anita Weaver/Donna Ritco to accept the Maintenance and Mowing contracts as presented and continue to looking to fill the toilet cleaning contract. Carried.

<u>New Address Numbering</u> – As part of the Provincial Government Address Registry the Hamlet have received new address numbering from the RM. Motion: Bill Scheck/Peter Olesko – Hamlet will invest in new street signs and posts, hamlet residence will be responsible for installing new house numbers. Carried.

- Clinton to check with RM as to where to obtain new signs/posts.
- Residents can also find their Cabin # on their Power Bill.

<u>Dumpsters</u> – on continuous contract, recycling is located in Livelong. Pickups are Wednesday. Fish guts should be frozen and taken to the dumpsters Tuesday night. These are not for construction materials! Contractor should have their own bins.

<u>Snow Removal</u> - Gerry Nasby continues to do a great job in snow removal, grading and boat launch dock placement.

New RM Bylaw – The Rural Municipality of Mervin #499 enacted Bylaw #2013-13 A Bylaw to regulate the parking of recreational vehicles on Municipal Property. Residents are encouraged to read the new bylaw which defines the limits (24hrs) for parking of recreational vehicles (vehicle designed as a living space) on streets, laneways (any legal Right of Way) within the RM. Benches – The Hamlet currently owns 10 benches. Several of the benches are becoming unsafe and are in dire need of repair. It was discussed to overhaul them with zero maintenance materials at a cost of \$530/bench. – Motion: Bill Scheck/Al Rallison – to retrofit four benches and assess if we would proceed with more next year. Carried.

• Picnic Tables – Are in good shape, will be sanded and repainted.

<u>Fire Hall</u> – The Fire Hall roof needs re-shingling. Motion – Donna Ritco/Don Taylor – to secure three quotes for installing tin on the Fire Hall roof and proceeding with the best quote. Carried.

• Hamlet Sign – the Hamlet sign support posts have rotted. Al Rallison offered to donate metal piping to replace the damaged wood. Thank you Al.

<u>Boat Launch</u> – Ice has moved the Boat Launch pads. Work will need to be done to reposition the pads. Motion: Anita Weaver/Dave Crump –to secure quotes/permits for repair and proceed. Carried.

<u>Boat Launch parking, and damage</u> – continues to be an issue. Board will look into having signs made to indicate areas of acceptable parking. As well damage to the dock is continuing. Motion: Don Taylor/Donna Ritco – That the Hamlet put out signage, flyers and a collection box for donations of \$10 per launch. Funds will go towards launch and parking lot maintenance. Hamlet Residents would be exempt from payment. Carried.

Clinton to follow up with RM if there is any issues with the \$10 ask.

<u>Beach Clean-up</u> – Residents can once again take winter materials from the beach and place at the back of their lot. Don will haul away.

<u>Parks and Turtle Lake Watershed Memberships</u> – Motion: Don Taylor/Ed Chudy – Renew Memberships for both. Carried.

<u>Dust Control</u> – Discussion on need for dust control and required graveling this year. Donna Ritco/Peter Olesco - to have dust control and gravel where required for the Hamlet. Carried. <u>Swimming Lessons</u> will be at South Bay June  $30^{th}$  to July  $5^{th}$ , Moonlight Bay July  $14^{th}$  –  $19^{th}$ , again July  $21^{st}$  to  $26^{th}$ , and finally Aug  $18^{th}$  –  $23^{rd}$ . Reserve Land – Ed Chudy asked about replacing some post barriers around a turn on Beach Ave. S. Clinton will check with the RM on impacts/liability.
